

Warranty Valid only in the Contiguous United States

This Limited Warranty ("Warranty") is presented by USR Brands ("Company"), covering the Prepline Food Equipment series: CSP/FSP/FSS/DR series dough sheeters, HBS series meat slicers, PLC/PFP/PCFP series food processors, PIB series immersion blenders, MIX series blenders, FM32/MC series meat grinders, B20/B30/PHLM series planetary mixers, HFW series food warmers, EST/GST series steam tables, EDG series electric griddles, IC series induction cookers, MPN/MPI series heater proofers, BDW/DW series drawer warmers, SLO/FCOE/HCVE series ovens, ERC series rice cookers, PCM/PACM/PAICM series coffee makers, PSP/PSPS/PSPT series scales, PLS64 series bone saws, PT-4S commercial toaster, FD-10R food dehydrator, CW3-5 cheese warmer, GP-5B glass polisher, JUICEFASTER/JC-600 series juice extractors, T-series cooking equipments.

One (1) Year Parts and Labor Warranty

USR Brands ("Company") warrants that for a period of one (1) year from the original date of delivery, when purchased from an authorized dealer, the eligible products from the Prepline Food Equipment series will be free of manufacturing defects. This warranty applies solely to the original purchaser and does not cover components or accessories sold separately. The Company's liability under this warranty is limited to the repair of the defective product. Under no circumstances will expenses covered by the warranty exceed its original purchase price. At the Company's discretion, store credit may be provided instead of repair. This stipulated remedy is the **SOLE AND EXCLUSIVE REMEDY** for claims under this warranty.

Warranty Coverage

This Warranty exclusively covers defects arising from the product's manufacturing or workmanship during standard usage as prescribed in the USR Brands' instructions. The Warranty does not cover:

- Damage resulting from deliberate or accidental misuse, abuse, unauthorized alterations, vandalism, improper handling, inadequate maintenance, or storage;
- Damage caused by fire, flooding, natural disasters, power fluctuations, improper utility connections (such as using the wrong voltage, phase, or fuel type), or any other external factor;
- Assembly, installation, or usage in disregard of USR Brands' guidelines;
- Gas, plumbing, and hardwired electrical connections that are not completed by a qualified installer (any necessary calibrations or other adjustments are the responsibility of the installer and are not covered under this warranty);
- Unconventional or unintended usage;
- Normal wear and tear, including parts subject to routine replacement, such as gaskets, light bulbs, loose fasteners on door or lid hinges, and the like;
- Corrosion or damage due to exposure to moisture;
- Usage of the product for non-commercial purposes;
- Labor, materials, or expenses incurred for removal, reinstallation, or replacement of the product;
- **Residential Installations:** USR Brands equipment is designed solely for commercial food service use. Warranty will not extend to residential use. We do not recommend using commercial food service equipment in residential settings;
- **Farm Installations:** Due to inconsistent electrical construction and safety standards, Farm installation warranties will be Parts Only. USR Brands Inc. is unable to send commercial food service technicians to perform any diagnoses or repair at a residential or farm location. We will ship covered parts for the duration of the warranty;
- **Food Truck Installations:** Due to difficulty accessing and servicing equipment in food trucks, food truck installation warranties must be limited to parts only. Onsite labor is not offered to food truck installs. Defective parts will be replaced at no cost to the buyer for the length of the warranty;
- **Glass:** Due to its fragile nature, glass is not covered by warranty. If an item arrives with broken glass, we encourage end users to refuse the shipments unless it's an easily replaceable piece like a door. If you receive an item with broken glass we will do our best to get you a replacement quickly and at low or no cost.

USR Brands does not maintain service contracts, and for this reason, cannot ship to, or guarantee products in the following western US states: CA, OR, WA, MT, WY, UT.
